The Show Site will be available to exhibitors on Wednesday (subject to Building & Show Committee). The **ONLY** people allowed in before 12:00 pm will be working Kennel Club members. **Please Do Not Attempt to enter the building or set up early.** Building will open at 6:00 am Thursday, Friday, Saturday & Sunday & will close at 11:00 pm Wednesday, Thursday, Friday & Saturday nights. Dogs must be removed from the show site immediately following Best in Show judging on Sunday.

Club members may exhibit at these shows.

This is a self clean up show. Please pick up after your own dog.

**RESERVED GROOMING & FREE GROOMING** - See premium list for information on reserved grooming. Free grooming is first come first serve. Will be available after Onofrio is finished with ring set-up or after 1:00 pm on Wednesday, whichever is later. BATHING allowed in designated area, facility has cold water only. Bring your own hoses, tubs, etc.

**EXERCISE PENS** - Absolutely no private exercise pens or drop pens will be allowed on concrete surfaces. Exercise pens are allowed outside. Keep exits and sidewalks clear.

**CRATING** - Crating and grooming in designated areas only. Exhibitors will be responsible for keeping their crating and grooming areas clean. The Show Committee reserves the right to require crates to be moved if the committee feels the crates are interfering with the orderly conduct of the show. **CRATES SHALL BE MARKED WITH CONTACT NAME & PHONE NUMBER FOR EMERGENCIES.**

**NO SMOKING** inside building. **NO FOOD OR DRINK** inside the building except that provided by the concessionaire. **SECURITY OFFICERS** will be on duty October 25-29, 2023 from 6pm to 6am but will not be responsible for property or dogs left overnight. The clubs have become aware of incidents of theft of personal property at shows. Exhibitors should not leave valuables unattended.

**PUBLICATION RIGHTS:** By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

**NEW EXHIBITOR BRIEFING** on Saturday. Check Judging Program for time & location.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 4) These Fees are paid to the American Kennel Club.

**CANADIAN/FOREIGN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.**

Entries received prior to the published opening date and time of entries or received prior to the publishing of this premium list will be returned without processing.

A service/processing fee of \$7.00 will be charged to each duplicate entry.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks nor will they be accepted toward entry fees.

**RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS** do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$4.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.50 will be charged for all cancellations or changes made prior to closing of entries.

**EXHIBITORS NOTE:** Please notify Superintendent of any change of address.

Each Entry processed through Jack Onofrio Dog Shows Telephone Entry Service or Onofrio Online Entry will have a service fee included in the amount charged to the payment card provided. Each user of either service acknowledges they are authorized to charge fees to the card provided for payment and further acknowledges the transaction is made over the phone or internet. **Section 1- Classifications**

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

**Section 2 – Entry and Eligibility**

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month Beginner Puppy Competition.

**OPEN SENIOR CLASS** - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.
