ATTENTION EXHIBITORS

The Show Site will be available to exhibitors on Thursday (subject to Building & Show Committee). The ONLY people allowed in before 12:00 pm will be working Kennel Club members. **Please Do Not Attempt to enter the building or set up early.** Building will open at 6:00 am Friday, Saturday & Sunday & will close at 11:00 pm Thursday, Friday & Saturday nights. Dogs must be removed from the show site immediately following Best in Show judging on Sunday.

Club members may exhibit at these shows.

This is a self clean up show. Please pick up after your own dog.

RESERVED GROOMING & FREE GROOMING - See premium list for information on reserved grooming. Free grooming is first come first serve. Will be available after Onofrio is finished with ring set-up or after 1:00 pm on Friday, whichever is later. BATHING allowed in designated area, facility has cold water only. Bring your own hoses, tubs, etc.

EXERCISE PENS - Absolutely no private exercise pens or drop pens will be allowed on concrete surfaces. Exercise pens are allowed outside. Keep exits and sidewalks clear.

CRATING - Crating and grooming in designated areas only. Exhibitors will be responsible for keeping their crating and grooming areas clean. The Show Committee reserves the right to require crates to be moved if the committee feels the crates are interfering with the orderly conduct of the show. CRATES SHALL BE MARKED WITH CONTACT NAME & PHONE NUMBER FOR EMERGENCIES.

NO SMOKING inside building. **NO FOOD OR DRINK** inside the building except that provided by the concessionaire. **SECURITY OFFICERS** will be on duty October 28-30, 2022, but will not be responsible for property or dogs left overnight. The clubs have become aware of incidents of theft of personal property at shows. Exhibitors should not leave valuables unattended.

Bell County Expo Center prohibits the carrying of concealed weapons on the Exposition Center premises.

NO VEHICLES ALLOWED IN SHOW BARN AFTER 1:00 PM THURSDAY OR UNTIL AFTER COMPLETION OF BEST IN SHOW JUDGING ON SUNDAY. VENDORS MAY PULL VEHICLES INTO BARN AFTER BEST IN SHOW JUDGING.

Ringside crating must be removed IMMEDIATELY after showing.

The Travis County Kennel Club, Inc. does not agree to arbitrate claims as set forth on the Official AKC entry form for these events.

The following breeds may be judged on the ground or on a ramp: Lagotti Romagnoli, Nova Scotia Duck Tolling Retrievers, American Water Spaniels, Boykin Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Grand Basset Griffon Vendéens, German Pinschers, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs and Norrbottenspets (Misc).

The following breeds may be judged on the ground, a ramp, or on a table: Whippets and Miniature Bull Terriers.

The following breed may be judged on a ramp or on a table: Mudi

The following breeds must be judged on a ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Cirneco dell'Etna, Basset Hounds, Bulldogs, Chinese Shar-Pei, Chow Chows and Keeshonden.

PUBLICATION RIGHTS: By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

NEW EXHIBITOR BRIEFING on Friday. Check the Judging Program for time & location.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 4) These Fees are paid to the American Kennel Club.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

Entries received prior to the published opening date and time of entries or received prior to the publishing of this premium list will be returned without processing.

A service/processing fee of \$7.00 will be charged to each duplicate entry.

Dogs need to be present only for scheduled judging and will be released if not needed for further judging.

Dogs are allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks nor will prize checks be accepted toward entry fees.

RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$3.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.50 will be charged for all cancellations or changes made prior to closing of entries.

EXHIBITORS NOTE: Please notify Superintendent of any change of address.

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month Beginner Puppy Competition.

Entries will close Wednesday Noon, October 12, 2022 at the Superintendent's office.

JUNIOR SHOWMANSHIP COMPETITION

The Travis County Kennel Club, Inc. has opted out of the AKC Junior Showmanship Canine Partners Pilot Program. Each dog entered in a regular Junior Showmanship Class must be an AKC registered purebred or FSS Breed with an AKC number and at least 6 months of age on the day of the event.

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards★, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards★ in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

★ A first place in Novice without competition leading to a Best Junior award with competition counts as one win towards moving to Open.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants to professional handlers may not exhibit the dog in any AKC National Owner-Handled Series competition during the entire show. A current assistant is defined by anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend, however current assistants that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may participate in NOHS.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*
